

TERMS AND CONDITIONS OF PARTICIPATION IN THE PROJECT "SCORES FOR BELONGING WITH YANIRA CASTRO IN KRAKÓW"

I. General Information

1. The Organizer of the Project "Scores for Belonging with Yanira Castro in Kraków", implemented under the program GPS/Global Practice Sharing Program of Movement Research, with financial support from the Trust for Mutual Understanding, (hereinafter referred to as the "**Project**") is the Nowa Huta Cultural Center (Nowohuckie Centrum Kultury), al. Jana Pawła II 232, 31-913 Kraków, NIP: 675-000-65-76, REGON 001002538.
2. Participation in the Project is equivalent to the acceptance of these Terms and Conditions of Participation (hereinafter referred to as the "**Terms and Conditions**").
3. The Project will take place from May 7–20, 2026, according to the schedule established by the Organizer.
4. Whenever these Terms and Conditions refer to:
 - a) **Organizer** – it shall mean the Nowa Huta Cultural Center, al. Jana Pawła II 232, 31-913 Kraków;
 - b) **Participant** – it shall mean a person who is at least 18 years of age and in good health, allowing for participation in the Meeting and Workshops within the Project;
 - c) "**Communal meal**" **Meeting** – it shall mean a meeting led by Yanira Castro, held on May 9 and 10, 2026, at the Nowa Huta Cultural Center building;
 - d) "**Community workshops**" – it shall mean performance workshops with Yanira Castro taking place from May 11–14, 2026, at the Nowa Huta Cultural Center and outdoors in the Nowa Huta district;
 - e) "**Scoring Freedom**" **Workshops** – it shall mean movement workshops with Yanira Castro taking place from May 16–17, 2026, at the KCC Studio in the Nowa Huta Cultural Center.

II. Registration for the "Communal meal" Meeting and "Community workshops"

1. Registration for the "Communal meal" Meeting and "Community workshops" begins on **February 24, 2026**. The number of places is limited and enrollment is on a first-come, first-served basis. Due to the nature of the workshops, the group size is not expected to exceed 15 people.
2. Registration is completed by accepting the workshop terms and conditions and filling out the online application form available on the Organizer's website: www.krakowskiecentrumchoreograficzne.pl.
3. Only persons defined as Participants in point I.4.b are eligible to participate.
4. Participation in the Meeting and Workshops is **free of charge**.
5. The Organizer reserves the right to limit or increase the number of places or close the registration list at any time. In the event of insufficient applications, the Organizer reserves the right to cancel the Meeting and/or Workshops. In such a case, Participants will be notified via email.

III. Registration and Fees for "Scoring Freedom" Workshops

1. Registration for the "Scoring Freedom" Workshops begins on **April 8 16, 2026**. The number of places is limited (first-come, first-served). The group size is not expected to exceed 15 people.
2. Registration is completed by accepting the terms and filling out the online application form at www.krakowskiecentrumchoreograficzne.pl.
3. Upon receiving email confirmation from the Organizer regarding qualification for the Workshops, the Participant is obliged to immediately make a payment to the bank account of the Nowa Huta Cultural Center: **PKO Bank Polski 72 1020 2892 0000 5002 0648 1669**.

4. **Fees:** 250 PLN (two hundred fifty Polish Zlotys) for 2 days of Workshops.
5. NCK does not issue refunds for Workshop fees paid by the Participant.
6. No applications or payments should be made if information regarding the closing of the group is posted on the website or sent via mailing (this does not apply to persons who received a qualification email according to point II.4).
7. If the Workshops are cancelled by the Organizer due to insufficient enrollment, the fee will be refunded in full to all Participants who made a payment.

IV. Participants

1. Participants are required to arrive at the Nowa Huta Cultural Center at least 10 minutes before the start of the Workshops to complete the registration procedure.
2. The Organizer is not liable for any injuries or accidents involving the Participant. Participants should obtain personal accident insurance (NNW) at their own expense.
3. The Organizer is not responsible for valuables or other property that may be lost, damaged, or stolen.
4. The Organizer reserves the right to remove any Participant who disrupts the proceedings or fails to follow the instructions of the instructor or the Organizer's representatives. It is strictly forbidden to be under the influence of alcohol or psychoactive substances. Smoking and the use of drugs are prohibited.

V. Information Clause and Data Processing (GDPR)

3. **Your Rights:** You have the right to access, rectify, or delete your data, limit processing, object to processing, and the right to data portability. You also have the right to lodge a complaint with the President of the Personal Data Protection Office (PUODO).
4. **Purpose of Processing:** We process your name and surname solely to organize and conduct the Workshops. Providing data is voluntary but necessary to participate.
5. **Profiling/International Transfer:** No profiling is used. Data is not transferred to third countries or international organizations.
6. **Legal Basis:** Performance of a contract (Art. 6(1)(b) GDPR).
7. **Storage Period:** Data will be processed for a period of 3 months.
8. **Recipients:** Data is shared only with entities processing data on behalf of the Organizer.

VI. Recording and Use of Image

1. By completing the application form, the Participant consents to the recording of their image in the form of photographs and film.
2. The Participant consents to the use of their image by the Organizer for documentation and promotional purposes, including publication on the Organizer's websites, social media, posters, and in photography exhibitions.
